**Consent To Operate ( EXPAN ) under Section 25/26 of the Water (Prevention & Control Pollution) Act, 1974 and under section 21 of the Air (Prevention & Control of Pollution) Act, 1981, as amended is granted in favour of**

**Sh. Harbinder Singh**  
**M/s National Hospital,**  
**Airport Road, Karan Bagh, Jammu (registered with District**  
**Registering Authority (CMO) Jammu) vide Provisional Registration**  
**No. 0102101307 dated 20/01/2025)**

for a period **up to 30/06/2026** for **GREEN** category of **Health Care Facility (HCF)** as per revised classification of industrial sector, subject to the following terms and conditions in a time bound manner:

1. The consent granted by the Committee is restricted to Prevention and Control of Pollution only and shall not be treated as substitute of permission required under other laws of the land.
2. The consent granted is valid for operation of Health Care Facility (HCF) as mentioned below with capital investment of Rs.43.42 lakhs (as per Schedule II) with ETP in the premises along with other pollution control equipments as per the provisions of the Air Act and Water Act.

Any change / enhancement in bed capacity / line of activity / inclusion of new activity etc shall have to be intimated to the Committee and the HCF Authority has to apply afresh for the same

3. **Compliance under Water Act:**

- a) Trade Effluent: The HCF has to install and maintain continuous operation of a comprehensive effluent treatment system consisting of Primary / Secondary / Tertiary treatment so as to achieve the quality of the treated effluent to the following standards of discharge outlet

**Standards of Discharge for Trade Effluent:**

| Compulsory Parameters             | Conc. in mg/l except for pH |

| pH                                | 6.5-8.5                     |
| Suspended Solids                  | 100                         |
| BOD (3 days at 27 degree Celsius) | 30                          |

- b) Sewage Effluent - The HCF has to install and maintain continuous operation of a comprehensive treatment system as is warranted with reference to effluent quality and operate and maintain the same continuously so as to achieve the quality to treated effluent to the following standards before disposal :-

**Standards of discharge for Sewage disposal:**

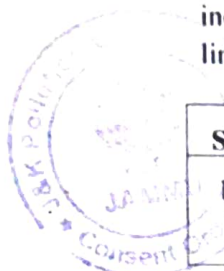

c) Water consumption & Disposal

- i. The daily quantity of water consumption shall not exceed prescribed limit.
- ii. The daily quantity of sewage effluent from the unit shall not exceed prescribed limit.
- iii. Waste water generated from the unit shall be disposed after prescribed treatment.

4. **Compliance under Air Act :**

- a. The HCF shall comply to National Ambient Air Quality Standards as per EP Act 1986 (refer rule 3(3B).
- b. The HCF authority has to operate stack(s) of the following specifications defined in various environmental laws:
- c. The HCF has to install and maintain continuous operation of a comprehensive air pollution control system including the following pollution control devices to achieve the quality of emissions within the tolerance limits as prescribed under the Environment Protection Act 1986:

5. The HCF shall comply to the Solid Waste Management Rules 2016 dated 8-4-2016.
6. Under the Noise Pollution (Regulation and Control) Rules 2000, the HCF shall take adequate measures for control of noise from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75dB(A) during day time and 70 dB(A) during night time. Daytime is reckoned in between 6 am to 10 pm and night time is 10 pm to 6 am.
7. The HCF shall comply to the Plastic Waste Management Rules 2016 dated 18-3-2016.
8. **Self Monitoring Schedule :**  
The HCF shall have to get the samples of emission/Effluents analyzed from the laboratory of J&K PCC or laboratories approved by J&K PCC/Competent Authority, at the time of operation to the check the efficacy of Pollution Control Devices (PCDs) installed in the HCF.
9. The HCF shall comply with the additional conditions as stipulated below:-
  - i. The HCF has to keep a record of the environmental data monitored regularly with regard to operation and maintenance of pollution control devices viz air pollution and water pollution to achieve the desired standards notified in the EP Act.
  - ii. The HCF shall be liable to pay compensation in case any damage is caused to the environment.
  - iii. The HCF shall abide by the directions of the Committee which will be issued from time to time. Any infringement/violation or transgression of the statutory enactments of pollution control acts by the HCF shall be sufficient cause to prosecute the violator in conformity with relevant sections of Air/Water Act and Environment Protection Act in force.
  - iv. The HCF shall be under surveillance monitoring of J & K Pollution Control Committee.
  - v. The HCF shall provide adequate arrangement for fighting the accidental leakages/discharge of any air pollutant/gas/liquid from the HCF which are likely to cause fire hazard including environmental pollution.
  - vi. **The Committee reserves the right to review, amend, suspend, revoke etc. this consent and the same shall be binding on the HCF.**
  - vii. **The HCF shall not change the Line of Activity, undertake any additional activity & shall not upgrade the category of pollution without the prior approval from JKPC.**
  - viii. **The HCF shall utilise authorized source of water only with due permission from competent authority and shall not discharge hospital waste/waste water into any water body.**
  - ix. The HCF shall adhere to general standards terms and conditions of Water / Air Acts and compliance of environment standards as per environment protection act 1986
  - x. The HCF should apply 60 days in advance for renewal of consent before expiry the date of this Consent Order



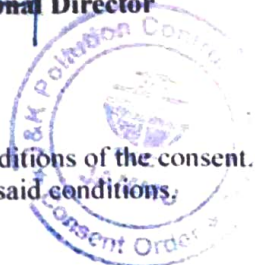
**Specific Conditions:-**

1. The HCF shall adhere to the general terms and conditions of Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act 1981 and ensure compliance of environmental standards as per EP Act 1986 and as amendments made thereof.
  2. The HCF shall operate all requisite pollution control devices in the HCF as envisaged under Bio-Medical Waste Management and Handling Rules.
  3. The HCF shall ensure segregation of liquid chemical waste at source and ensure pre-treatment or neutralization prior to mixing with other effluent generated from the facility.
  4. The HCF shall handover the waste generated to approved Common Biomedical waste treatment & Disposal facility.
  5. The HCF shall install Color Coded Bins with proper labeling in the HCF. Segregation of waste must be done at source.
  6. The HCF shall maintain the log book of ETP/APCDs/BMW and keep them operational/available during operation of the hospital and in case of default, the consent shall deemed to be withdrawn.
  7. The HCF shall establish a system to review and monitor the activities related to Bio-Medical Waste Management Rules.
  8. The HCF shall carry out the monitoring of ETP/APCDs from the JKPCC Lab once in a year besides SMR which shall be verified by the JKPCC Lab.
  9. The HCF shall submit compliance of conditions of consent to JKPCC and Divisional Office concerned as well on half yearly basis.
  10. The HCF shall ensure occupational safety of all its health care workers and others involved in handling of BMW by providing appropriate and adequate personal protective equipments.
  11. The HCF shall remain under the surveillance of JKPCC regularly.
  12. The Periodic inspection of the HCF shall be conducted by concerned Divisional Officer.
  13. The HCF shall strictly adhere to the BMW Rules, 2016 and amendments thereof.
  14. The HCF shall report major accidents including accidents caused by fire hazards, blasts during handling of BMW and the remedial action taken and the records thereto.
  15. HCF shall submit renewed DHS registration (within one month of its expiry) to Divisional Officer concerned, failing which consent granted shall deemed to be withdrawn. Further, consent granted earlier vide Consent No. PCC/digital/23063119409 of 2023 dated 06/03/2023 for 18 beds is hereby rescinded.
- xi. In case of violation of above mentioned conditions or any public complaint the consent shall deemed to be withdrawn.
